**Representative McClendon to Host
Town Hall Meeting
on May 8 at Woodlake Hills Middle School**

(San Antonio) – Representative Ruth Jones McClendon (D - San Antonio) will host a Town Hall Meeting on Thursday, May 8, at Woodlake Hills Middle School, 6625 Woodlake Parkway, from 6:30-8:00 p.m.

"We have realized in recent years that many residents and businesses of Bexar County are in developed areas which are surrounded by the municipalities of Windcrest, Kirby, Converse and the City of San Antonio, but these areas do not fall within any city's limits. The purpose of this meeting is to determine ways in which the state can bring relief to the residents and businesses in this unincorporated area in response to changes in the surrounding environments, by informing them of existing governmental services and those offered or which could be initiated by the state of Texas.
